Fortis Inc. (TSX:FTS) ("Fortis" or the "Corporation") today filed its audited Consolidated Financial Statements and related Management Discussion and Analysis for the year ended December 31, 2013, as well as its 2013 Annual Report and Annual Information Form, with Canadian securities regulatory authorities. Its regulated utilities account for 90% of total assets and serve more than 2.4 million customers across Canada and in New York State and the Caribbean. Fortis owns non-regulated hydroelectric generation assets in Canada, Belize and Upstate New York. The Corporation's non-utility investment is comprised of hotels and commercial real estate in Canada.
